In this policy, MRI-hyphen guided focal laser ablation of prostate (e.g., the Visualase Laser Ablation System), Irreversible electroporation therapy, dual-hyphen fiber laser ablation, photothermal ablation with copper sulfide nanoplates, focal thermo-hyphen ablative therapy, local therapy/metastasis-hyphen directed therapy -hyphen no specific code.

Experimental and Investigational

Curative considers the following ablative procedures experimental and investigational for the treatment (primary or salvage therapy) of prostate cancer because their effectiveness has not been established (not an all-inclusive list):

- Dual-fiber laser ablation
- Focal thermo-ablative therapy for the treatment of oligometastatic prostate cancer (OMPC)
- Irreversible electroporation therapy <u>- Irreversible Electroporation (Nano Knife)</u>)
- Local therapy/metastasis-directed therapy for the treatment of oligo-metastatic/oligo-progressive prostate cancer
- Magnetic field induction ablation

- Magnetic resonance imaging (MRI)-guided focal laser ablation (e.g., the Visualase Laser Ablation System)
- MRI-guided transurethral ultrasound ablation
- Photothermal ablation with copper sulfide nanoplates
- Vascular targeted photodynamic therapy (also known as soluble focal therapy)
- Water vapor thermotherapy.
